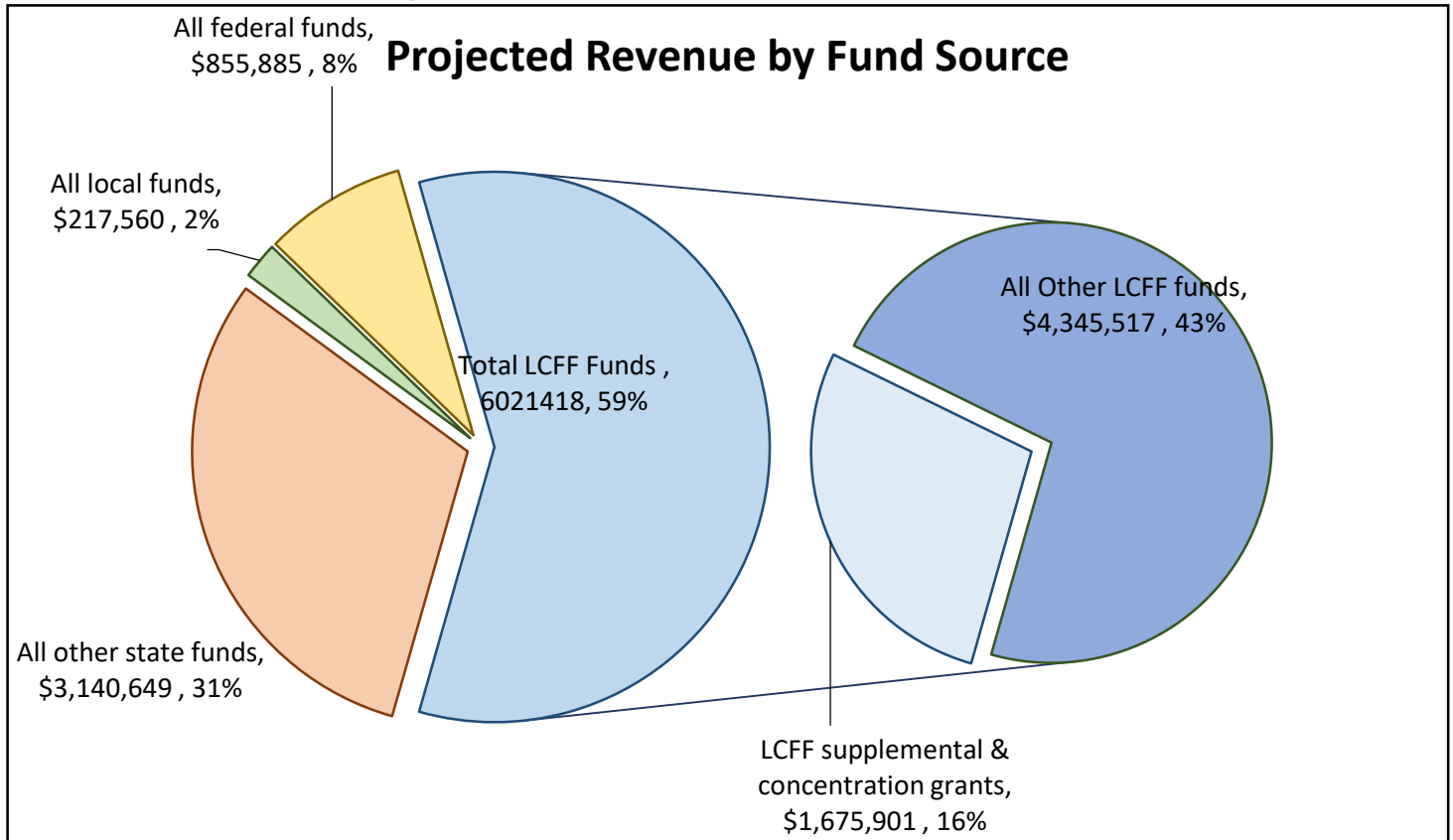

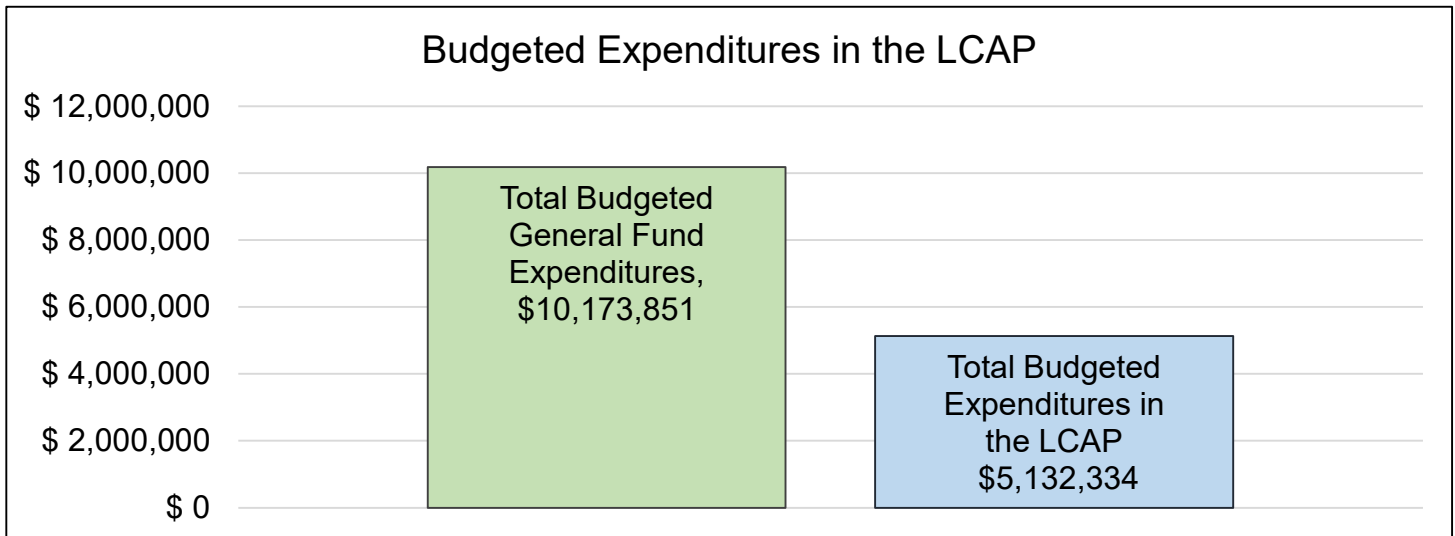


This chart shows the total general purpose revenue N.E.W. Academy of Science and Arts expects to receive in the coming year from all sources.

Of the \$6,021,418.00 in LCFF Funds, \$1,675,901.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

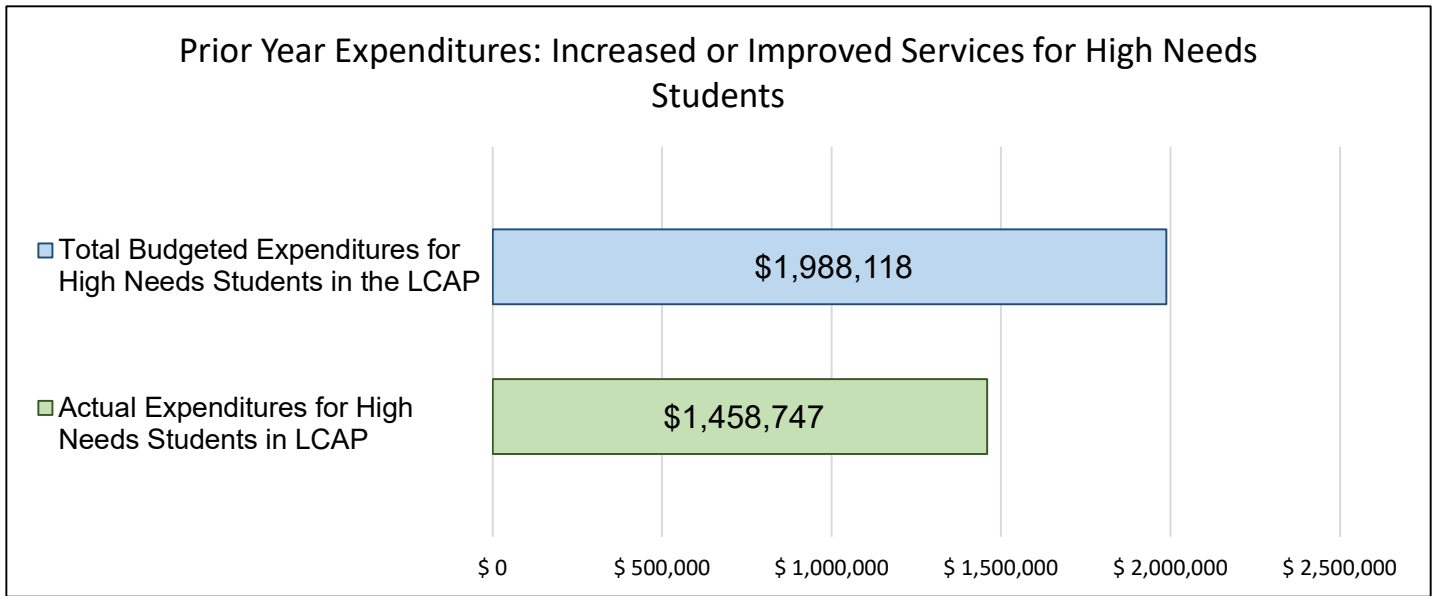

Plan Summary 2026-27

General Information

N.E.W. Academy of Science and Arts (NASA) is a Transitional Kindergarten through Fifth grade elementary school near downtown Los Angeles, in the Pico Union/Westlake neighborhood. The area was and is a high-density area that is largely populated with Latino immigrant families and identified with poverty. New Economics for Women, through its work to improve the lives of Latinas and their families, and as a community development organization in the early 2000s, saw the need for a school that would empower and help families in the Pico Union/Westlake.

N.E.W. Academy of Science and Arts was the inception of New Economics for Women and the school first opened its doors in 2003 upon authorization by LAUSD. It included goals for equipping low-income students for academic success and community participation in a child-centered environment where students work cooperatively, think critically and are self-directed as well as respect cultural diversity. We believe that this innovative approach sets us apart from other schools.

N.E.W. Academy of Science and Arts serves a unique Los Angeles community. As stated earlier NASA is located in the Pico Union/Westlake neighborhood, and in 2024-25 NASA served a population of about 417 students of which 98.3% are Hispanic/Latino. According to enrollment applications and CALPADS data, all of our students come from low socioeconomic means, and 99.8% qualify for free and reduced meals. Approximately 11.8% are students with disabilities and 65.2% are currently classified as English Learners. Informal anecdotal information has shown some of our Guatemalan parents speak a Mayan dialect with some broken Spanish and that some of our parents do not read or write. The Los Angeles Times Mapping Project describes the neighborhood NASA serves as one of Los Angeles’ highest density, with an ethnicity of 73.4% Latino.

The purpose of this Local Control Accountability Plan (LCAP) is to address the School Plan for Student Achievement (SPSA) for N.E.W. Academy of Science and Arts which is the Schoolwide Program; herein referred to as the LCAP. The Charter School’s plan is to effectively meet the ESSA Requirements in alignment with the LCAP and other federal, state and local programs. The plans included in the LCAP address these requirements focusing on five goals. The school will monitor every students’ academic progress and student achievement as measured by assessment data. The Charter School completed a comprehensive needs assessment of the entire school which included an

analysis of verifiable state data and local performance data used to measure student outcomes as evidenced in the annual update portion of the LCAP. The needs assessment process included meeting parents, classified staff, teachers and administrators to identify areas of opportunity for the students and groups of students who are not achieving standard mastery and to identify strategies which will be implemented in the LCAP to address those areas of opportunity.

The identification of the process for evaluating and monitoring the implementation of the LCAP and the progress toward accomplishing the established goals will include discussing the actions and services with the use of supplemental funds at the school level through the Parent Advisory Council which will include parents of English Learners. The Parent Advisory Council will meet four times per year to inform the process. Parents, classified staff, certificated staff and an administrator will make up the council. The number of parents will exceed or be equal to the number of total staff members. The council will discuss academic performance, supplemental services and areas to make improvements with Title funds as part of the School Plan included in the LCAP conversations at the meeting in the fall and at the meeting in the spring. The teachers, staff, students and parents also participate in an annual survey which provides feedback on the goals and services. The teachers, staff and administrators actively participate in the decision making process throughout the year and during LCAP workshops. The decisions will take into account the needs of N.E.W. Academy of Science and Arts based on student achievement data to include SBAC, ELPAC, and interim assessment data, cumulative assessments, and attendance and student demographic data to include all of the significant subgroups. This student achievement data and student demographic data will be used as a basis for making decisions about the use of supplemental federal funds and the development of policies on basic core services.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

N.E.W. Academy of Science and Arts is very proud of its Yellow status for all students and subgroups in Math and English Language Arts achievement on the 2025 CA Dashboard, which reflects an improvement from last year. We will continue to implement consistent math and ELA intervention supports in order to continue to increase student scores.

We are also proud of our 0% suspension rate, which helped us achieve Blue level status on the 2025 CA Dashboard. We attribute this to the school climate action and we are committed to continuing to provide a positive environment for all students.

The positive culture at NASA has been highlighted through survey results which demonstrate that 97% of families responded positively regarding school safety and 95% responded positively regarding school connectedness. Students have also given highly positive feedback with 91% of students responding that adults always care about students.

Based on the 2023 CA Dashboard, the school has identified needs based on the Red status for students with disabilities in English Language Arts achievement. To address this need, the school will maintain a high level of support staff to assist with ELA intervention. Also, the school will ensure that all students with disabilities are provided targeted academic support in addition to comprehensive special education services. The school will continue to prioritize academic intervention for all students in order to support ELA achievement.

Learning Recovery Emergency Block Grant (LREBG)

NASA has \$60,078.50 in unexpended LREBG funds that it will be utilizing for the 2026-27 school year. The LREBG funded action can be found in Goal 1, Action 6 Targeted Instructional support.

The NASA needs assessment substantiated findings from the 2025 CA Dashboard related to academic achievement in English Language Arts and Mathematics. A review of state and local data indicates Students with Disabilities have significant needs in these areas. The needs assessment found that students need additional instruction to meet grade level standards. Based on this, Goal 1, Action 6 directly addresses these needs by providing academic support for those who are struggling in ELA and Math. This action falls under the allowable uses of the funds by furnishing additional aides to assist with intervention.

Goal Analysis for 2025-26

Overall the actions designed to support achievement of the goal were implemented as planned.

Successes with the action implementation process include that NASA has hired new RSP teachers to complete our Special Education team; students are receiving amazing support and showing continuous progress. In addition, our teachers have been integrating more English Language Development scaffolding in their classrooms, providing additional assistance for our English Learners. We have been prioritizing data analysis in order to make better decisions regarding instruction.

Some challenges with implementation this year include that some students are still lacking foundational skills, and it has been affecting their performance on exams. Additionally, we need to support the school community in better understanding our dual language program and the reclassification process.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Material differences between budgeted expenditures and estimated actuals occurred in these actions:

Action 1.2 Curriculum: Our curricular programming was less expensive than originally anticipated.

Action 1.4 Broad Course of Study: We had originally budgeted for a part-time art teacher, but were not able to hire one.

Action 1.7 Special Education: We were not able to hire for two RSP teacher positions.

Action 1.9 Technology Access: We purchased fewer computers than originally planned.

Action 1.11 Assessments: Our assessment costs were less expensive than originally anticipated

Action 1.12 ELD Professional Development: Staff did not end up attending the CAFE Conference this year.

Action 1.13 ELD Instructional Materials: ELD curricular materials were more expensive than originally anticipated.

The Broad Course of Study and Curriculum actions have been effective as evidenced by the Broad Course of Study Indicator (100%), students with access to standards aligned materials (100%), along with the adopted standards metric (100%). The Teacher Recruitment and Retention action and the Professional Development actions have also been effective as measured by our outcomes for teachers appropriately credentialed and assigned (58.8% appropriately credentialed).

Our actions related to instruction, including our Instructional model, Targeted instructional support, Special Education, Intervention and Technology Access actions, have been very effective as evidenced by CAASPP data (See Table). Almost every student subgroup has significantly improved in both ELA and Math. We will continue to employ targeted instructional support to help improve outcomes for all students.

Our ELD Professional Development, ELD Curricular Materials, Assessments and School Data Analysis actions were somewhat effective in implementation as evidenced by our ELPI score of 46.3% and our maintained reclassification rate of 11%.

Overall the actions designed to support achievement of the goal were implemented as planned.

Successes with the action implementation process include that students are motivated, engaged and happy to be at school. This is exemplified by NASA’s lowered chronic absenteeism, and 0% suspension and expulsion rates. NASA students have been exhibiting the pillars of character that we strive for.

Some challenges with implementation this year include that certain families are still struggling with attendance; we are discussing ways in which to better incentivize them. Additionally, the environment surrounding the school campus has had challenges with homelessness; we are strategizing with how best to utilize our security guards to keep students safe.

Material differences between budgeted expenditures and estimated actuals occurred in these actions:

Action 2.2 Mental Health: We were unable to hire for the school psychologist position that we had originally budgeted for.

Action 2.3 Health and Safety: Our health and safety budget was higher than anticipated.

Action 2.4 PBIS and Restorative Practices: Our staffing costs were lower than anticipated.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Our PBIS and SEL actions were effective as measured by our outcomes for suspensions (0%) and expulsions (0%). The effectiveness of these actions on developing a safe and welcoming school culture is also evident from our student survey data showing 91% of students agree that adults always care about students. In regard to teacher feelings regarding school connectedness, 80% responded positively. We will continue to prioritize school culture and implement teacher feedback to encourage engagement in the coming year.

Our Attendance Initiatives action have been extremely effective as measured by our high ADA (96.03%) and chronic absenteeism (13.1% for all students).

Our Health and Safety action was successful as measured by the 91% of students reporting that they always feel safe on campus, the 97% of families that responded positively regarding safety and the fact that our facilities have been deemed to be in “good repair”. 80% of teachers responded positively regarding safety, which represents a 3% increase from the baseline.

 - This percentage is the Estimated Actual LCFF Supplemental and/or Concentration Grants (6) divided by the Estimated Actual LCFF Base Grant (9) plus the LCFF Carryover – Percentage from the prior year.
- **11. Estimated Actual Percentage of Increased or Improved Services (7 divided by 9, plus 8)**
 - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- **12. LCFF Carryover — Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)**
 - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.
- **13. LCFF Carryover — Percentage (12 divided by 9)**
 - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
